Justice Hart was appointed by Governor John Hickenlooper to serve on the Colorado Supreme Court on December 14, 2017. Prior to joining the Court, Justice Hart was a professor at the University of Colorado Law School, where she directed the Byron R. White Center for the Study of American Constitutional Law. Her teaching and scholarship focused on access to justice, constitutional law, judicial decision-making, legal ethics, employment discrimination, and civil procedure. She is a member of the Colorado and Denver Bar Associations, the Colorado Women's Bar Association, the Colorado Hispanic Bar Association, the Asian Pacific American Bar Association, the Sam Cary Bar Association, and the Colorado LGBT Bar Association; and is a founding member of the Sonia Sotomayor Inn of Court.

**Forensic analytics and Trauma-Informed Justice**

As legal professionals and members of a community, we should anticipate having to serve and accommodate individuals who may be experiencing mental hardship. Therefore, it is on us to keep ourselves educated and informed about trauma and how it affects individuals. The goal of this panel is to give educational tips and provide methods so that attendees can be more trauma-informed going forward. This will include information on how to communicate with someone experiencing psychosis, how to make sure a person with anxiety is tracking and understanding what their legal counsel is saying, and other ways of approaching such situations with as much awareness as possible. The need for mental health reform is becoming more apparent with every passing year. One of the key areas needing reform is mental health legislation. The goal of this panel is to give attendees an overview of the current state of Colorado's mental health legislation and the legislative process. This panel will discuss C.R.S. §27-65, the codified system of Colorado's mental health care and procedures of involuntary treatment, as well as the drafting process of said legislation. This panel will feature: Lauren Snyder, the Vice President for Government Affairs for Mental Health Colorado who works in collaboration with lawmakers and advocates to create statewide policy; Jonathan Culwell, a practicing attorney in dealing with mental health litigation, and a board member for both National Alliance on Mental Illness, Colorado, and for the Colorado Guardianship Association; Meghan Baker, a former public defender and current attorney at Disability Law Colorado advocating for people with disabilities in jails, prisons, and other facilities; and Michael Whitlow, a former prosecutor now a professor at the University of Denver, Sturm College of law, and an expert in legislative drafting.
